



# VOTING

#### The by-laws of Christ Church Cathedral provide:

- Eligible voters are: baptized, confirmed or received communicants 16 years or older; on the parish roll for at least 6 months; regular contributors to the support of the parish.
- Voting will begin at 8:00 am on Sunday, December 8 and continue throughout the morning until 1 hour after the conclusion of the 11:00 service.

# **HOW TO VOTE**

**Vestry Elections.** Each eligible voter will **vote for four** Vestry members. The four with the most votes will begin their service in January.

**Convention Deputy Nominees.** Each eligible voter will **vote for four** Convention Deputies. The four with the most votes become Deputies.

Voting for less or more than four Vestry candidates AND less or more than four Deputy candidates renders your ballot VOID.
